Dear Christine Holowka:

Your letter of January 24, 2022, addressed to Honourable John Horgan, Premier, regarding the National Day for Truth and Reconciliation has been forwarded to me for response.

As you know, the federal government passed legislation in June 2021 to designate September 30 a statutory holiday for federal employees and federally regulated employers. This was done in direct response to the Truth and Reconciliation Commission's Call to Action #80.

This past year, the provincial government advised public sector employers to observe September 30 as a holiday in recognition of the obligations in many collective agreements. I, along with the Honourable Selina Robinson, Minister of Finance, released a statement in August 2021 communicating our intent to engage Indigenous partners and communities on the most meaningful and appropriate way to mark September 30 moving forward. We acknowledge that the views of residential school survivors and their families are most important in shaping how we observe the National Day for Truth and Reconciliation each year. These engagements will occur over the coming months.

As you have highlighted in your letter, the National Day for Truth and Reconciliation offers an important opportunity for Indigenous and non-Indigenous people to come together to acknowledge our colonial history and the impacts of the residential school system. The importance of engaging and educating non-Indigenous peoples has come into much clearer focus with the continued findings of unmarked graves on the grounds of former Indian Residential Schools throughout British Columbia and across Canada. While these truths have always been known by residential school survivors and are well documented in the final report of the Truth and Reconciliation Commission, many people are only now learning about the harmful history and legacy of the residential school system.

I appreciate your observation about the need for employers to take the National Day for Truth and Reconciliation seriously and the role a provincial statutory holiday could play in facilitating public education, engagement, and reconciliation. To this end, we will be engaging businesses, workers, unions, and labour representatives in the months ahead on the ways in which employers can participate in and meaningfully contribute to the National Day for Truth and Reconciliation.

I appreciated the opportunity to read your letter. Your views as an Indigenous labour representative are valuable as we work with Indigenous partners and communities to determine what September 30 will look like in future years.
